

Notification of Retired Registered Greyhound

GA Rule 106(3) states

At any time after the registration of a litter, the last registered owner or person responsible for the greyhound at the relevant time, shall, within ten working days, notify the Controlling Body by lodging of the prescribed form, if that greyhound has transferred ownership, been retired as a pet or a breeding greyhound, been transferred to an adoption program, exported, surrendered to another agency, been humanely euthanased by a veterinary surgeon or deceased.
